# **B.** General Manager

- 15 Rentals were cancelled for the month of December. 5 of those were under deposit and were refunded. One was transferred to 2021.
- 2021 Dues and Election Ballot: 289 ballots were cast (250 last year) The breakdown of the vote is as follows:

2021 Dues: \$270 dues - 266 votes \$275 dues - 21 votes No amount - 2 votes

# Work completed at Hanford Clubhouse:

- Completed monthly PM.
- Repaired faulty filters from the pump room that were causing leakage into the guard room.
- Installed PVC drain lines from the filters to the sump pit.
- Winterized the tennis court.
- Met with NeverBlue (IT company) to resolve IT issues.
- Met with Comcast Business to install new phone system and backup battery system for the phone internet.

# Work completed at Gainsborough Clubhouse:

- Completed monthly PM
- Removed leaves from gutters around the building.
- Winterized Pickleball courts.
- Metro sewer completed cleaning and flushing out the pool backwash drain line. Recommend we run a camera down the line again at the end of next season to see if any new buildup is occurring.
- Replaced batteries in 3 thermostats.

# **Gainsborough Floor Project:**

• Waiting on Parris Construction Co. to establish a timeline for work.

Clean Cut was contacted to obtain an estimate of what services would be required to remove the lava rocks and restore the damage to the woods behind the Gainsborough Pool to a natural state.

Upright Fence was contacted again regarding the pool fencing heaving and the additional gate installation. Per the office, they are still behind in 2020 scheduled work, and cannot provide an estimator at this time. Work is now scheduled for the Spring of 2021 and is on the calendar for a reminder call in February.
