**FYI** - As we get ready for spring and summer, homeowners who own boats and campers will be getting them ready to use. Township ordinances allow temporary parking of boats and campers for



72 hours prior to and after use of recreational vehicles. However, homeowners can get a permit twice a year for two weeks to keep the vehicle/boat on their property while they prep it,

make repairs or clean it. The permit must be displayed on the vehicle/boat in a visible place.



# **Spring Clean-up**

As springtime rolls around, residents are reminded that Canton ordinance prohibits the burning of grass, leaves and other yard waste. Grass clippings, leaves and garden waste should be placed in 30-gallon paper yard waste bags or 32-gallon reusable containers with sturdy handles that are labeled "Yard Waste."



Twigs, branches, brush, pruning/wood debris must be tied with heavy twine into bundles no longer than three feet, branches no thicker than 1 1/2 inches in diameter, and weighing no more than 50 pounds.

Yard waste and recyclables should be

placed separately from trash on your regularly scheduled pick-up day.

#### 2021 DUES UPDATE



As residents of Sunflower, all of us share in the benefits and responsibilities of our Homeowners Association. The Board has tried to work with everyone to settle outstanding balances but there are a number of homes that are

delinquent. It is not fair to the majority of owners who pay the annual dues in a timely manner to have a few not pay and the Association not have the benefit of the additional revenues for the operations and improvements of the clubhouses and commons areas.

The Association will file a lien on the property if dues are not paid timely. If the liens are not paid, the Association will file a foreclosure lawsuit. If you are an owner who is delinquent on your dues, we highly recommend that you contact the Association and establish a payment plan for past dues and late fees. If the Association is forced to file a lien and foreclosure, the Association Board is committed to pursuing not only payment of dues and late fees, but also repayment of any and all associated legal fees.

To date, 1,603 homeowners (95.2%) have paid their 2021 dues (21 homeowners are on payment plans). Delinquent homeowners now owe \$375 for 2021 dues and late fees. Please send payment immediately to avoid legal action and expense. The Association still will offer a payment plan to homeowners who request one. Please call the office immediately — all details are kept confidential. Use of the pools and rental of the clubhouse is suspended until all dues and charges are paid in full.

# Picnic Update

We're all yearning to get back to life as it was before COVID, but sadly, we're just not there yet. The board of directors is watching the budget very carefully, and with the increase to minimum wages for summer staff, lack of revenue from clubhouse rentals, and a concern for the health and safety of the residents, the decision was made to cancel this year's picnic.

By this time each year the picnic team would be well into planning — activities would be blocked, tents and tables would be reserved, a menu would be planned and work would be underway for a well-coordinated day of fun. And each year, close to 1,000 neighbors and friends would gather to laugh, eat and enjoy a day of fun and games with family and friends, but as of now, only 300 people are permitted at an outdoor gathering.

Unfortunately, with the current state guidelines, and our limited budget, the Board felt it wasn't in Sunflower's best interest to hold the picnic this year. We're all sad, but looking forward to a bigger and better picnic's return next year.





This column addresses items of interest that homeowners raise.

- Q: Why not open the pools earlier in the morning rather than staying open until 9 p.m.?
- A: Swim lessons are offered in the mornings at the Gainsborough Pool. To accommodate them, the pools do not open until 1 p.m. A review of the attendance figures from previous years found that the pools are used more frequently between the hours of 8-9 p.m. than between the hours of noon and 1 p.m.
- Q: How do I find out if I can have a fence on my lot?
- A: Please review the Covenants & Restrictions, Section 9 (found under Legal Documents at www.sunflowercanton.com). A permit must be obtained through Canton Township.

# Q: Will the pools be open through Labor Day?

A: Every year we have to look at this question. The answer always depends on how many staff members we have available at the end of August. Our more experienced college guards will be leaving for school in mid-August. We need a college guard (over age 18) to handle the chemicals and pumps and we cannot leave the pools manned by just first-year guards for safety reasons. Once we see how the staff shapes up, the Board will be able to make decisions regarding the end of the season.

# STORM SEWERS IN HOMEOWNER'S EASEMENT

It is the responsibility of each individual homeowner to maintain, repair and/or replace the easement and improvements that service each lot (i.e. storm sewer), since this is the portion of the system that is for the sole benefit of each particular homeowner. The responsibility for maintaining and repairing same is set forth in the Covenants and Restrictions of Sunflower Village Homes Association. The storm sewers are in "private" easements and therefore neither Canton Township nor Sunflower Village Homes Association are responsible for their upkeep.

The Association is responsible for storm sewers located in the commons.

# **Important COVID Pool Rules**

The board is excited to be opening the Hanford and Gainsborough pools this summer, but there are still some special rules that must be observed this summer due to the ongoing pandemic.

The rising minimum wage and a lack of rental income have made it imperative for the Board to watch the budget closely. In order to control costs, the Board has made the decision to open the pools at 1:00 p.m. instead of noon as in other summers. A review of the attendance from previous years shows the hour between noon and 1:00 is the least used hour of the day with few residents in attendance.

As of this printing, we are permitted to open the pools at 50% capacity. This means each pool will be limited to a maximum bather load of **75 patrons**. We do not anticipate this being a problem and advance pool reservations will not be required at this time.

The lifeguards will remain inside a designated "red" lifeguard zones. Residents are asked to respect these zones and not cross into them.

COVID waivers will not be required at this time. If you are feeling ill, experiencing any symptoms of COVID or have recently been exposed to COVID, please DO NOT visit or use the Sunflower facilities. If you are notified that you have been exposed after you have visited one of our facilities, please contact the office immediately.

Masks should not be worn in the water, but we are still requesting masks be worn at the check-in cart and on the deck area.

The pool rules are subject to change as new information, policies and procedures are provided from the Wayne County Department of Health. Thank you to all of our residents for their cooperation and understanding as we navigate this strange time.

**Adult Swim -** The last 15 minutes of every hour. During adult swim all swimmers under age 18 are to be at least six feet back from the edge of the pool. The Hanford Kiddy Pool will be closed during adult swim.

Once the pool is open for the full summer hours, an additional adult swim will be from 8-9 p.m., Monday thru Friday at the Gainsborough Pool. During the evening adult swim the pool may be divided in half for adult-only lap swim on one side and open swim for all ages on the other side.

The Hanford Pool will remain open for all ages.

# **New Residents**

### **End of** Season

The end of the season closing times will be determined according to staff availability in August.

Since many of our college guards will leave in mid-August it may be difficult to remain open on a full schedule until Labor Day. We will make every attempt to stay open as long as it's safe for the patrons. Thank you for your understanding. Notice will be posted at the pools once closing dates are determined.



#### **NOTICE DUES & LATE FEES MUST BE PAID BEFORE YOU** CAN USE THE POOL

Pool Staff are not able to accept dues payments at the pool. Please pay at the office before the pools open for the season. Dues paid after the pool opens are subject to a five-day processing period. Dues payments will be processed only during normal office hours.

#### **CHECK-IN AT THE POOL**

Please check in every time you come to the pool.

- Indicate on the clip board at the check-in cart your lot number, number of residents and number of guests coming in.
- Have the lifeguard on duty punch your guest pass for each guest (or purchase a guest pass if needed).
- Ask a lifeguard if you don't know your lot number.
- Fill out a registration form if the lifeguard asks you to do so (it means we're missing some information that we need).
- Complete a COVID waiver if you are asked to do so.
- If no one is at the cart, please check-in anyway — it helps us keep an accurate count of pool
- If you have any questions about the pools, ask a lifeguard.

- Wednesday, May 12, 6-7 p.m. Hanford Clubhouse. **NO advance registration!**
- Residents whose dues are current may register their children on a first come, first serve basis. Children must be at least five years old to be registered.
- The registration form will require a parent's signature.
- Cost for a two week session Monday Thursday are: \$60 if pre-registered May 12-June 10 OR if you are registering the same child for a second session. (You must register for the second session before Thursday prior to the first day of the lessons.) Registrations after June 10 are \$65.
- All fees are due at the time of registration. Lessons will be at the Gainsborough Pool.
- Fridays are reserved for make-up sessions if class is canceled <u>due to bad weather</u>. If the temperatue is below 65 degrees at 9:30 a.m., lessons may be canceled for the day. No refunds will be issued for missed classes.
- Pre-testing will take place the week before each session. Sign-up for pre-testing will occur at the time of sign-up.
- Any registrations after May 12 will be handled through the office during normal business hours on a first come, first serve basis.
- Private lessons are not available.
- NO REGISTRATION WILL BE TAKEN AT THE POOL. The cut-off for registration is noon Thursday prior to the start of Monday's session.
- Non-residents (nieces, nephews, friends, etc) who register will be placed on a waiting list and will be notified by 3 p.m. the Thursday prior to class if openings are available. Cost for non-residents is \$65.

NO REFUNDS WILL BE GIVEN UNLESS THE SESSION IS CANCELLED DUE TO LOW ENROLLMENT

#### CHILDCARE PROVIDERS

A childcare provider is someone who is authorized to bring the children to the pool in the parent's absence.

Parents, your childcare provider must be registered with the association office.

15 years or older for children age 6 and older

18 years or older for children under the age of 6 Guest pass is required if they are NOT a

Registration MUST be done at the office each pool season. Lifeguards are not able to complete registrations at the pool.



Please wear proper swim attire when using the pools.



## THE POOLS ARE SMOKE FREE

Smoking is not allowed inside the pool fence Thank you for your cooperation.

#### Discipline Policy

To ensure a safe environment for all swimmers, the lifeguards will enforce our rules. If a child is asked to leave the pool due to a discipline problem, the parents will be notified by phone and also in writing. The child may not return to the pool without the notification signed by a parent. A copy of this policy is available in the Association office.

# No disposable diapers in the pool!

Swim diapers are

highly recommended (or use a cloth diaper and snug fitting rubber pants).

Swim diapers will NOT be available for

purchase.



Sunflower pools may not be used for private swim lessons by any party. Please do not approach our guards about private lessons using our facilities.

#### **POOL FUN**

What can we bring to the pool?

Small plastic pool toys (that fit in the palm of your hand) with no removable parts or sharp edges. Please no balls, noodles, dolls with hair, or flotation devices. (Water wings are acceptable.) The type of toy and the use of the toy will be up to the lifequard's discretion. Please respect the authority of the lifequards who are here to ensure your safety and enjoyment of our facility.

Non-alcoholic beverages in cans or plastic bottles (juice boxes are OK). Since food is not allowed on the pool deck, please enjoy your snacks outside the fenced area.

#### **REMINDER**

Children under the age of 6 MUST be accompanied in the water by an adult or qualified helper (see pool rules for helper qualifications on Page 10).



Children under the age of 12 MUST be supervised by an adult at all times. (Note: Children ages 9-11 who pass the RED DOT TEST may use the pool **Unsupervised. See Red Dot Test information** Below.)

Our lifeguard staff is there to ensure the safety of all the patrons at the pool — not to baby-sit individual children.

#### **Red Dot Testing**

required for all qualified helpers and for ages 9-11 swimming without adult supervision

- Testing will be done M-W-F from 8:00 to 9:00 p.m. at the GAINSBOROUGH POOL (once full summer hours start).
- Parents must sign up their children before 7:00 p.m. the day they want them tested.
- Parents must be on deck during the testing and will be asked to sit in a designated area while the child takes the test. Parents may not coach their child during the test.
- There is a one-week waiting period if a child needs retesting
- Parents must complete a "Red Dot Test" form before their child is tested.
- Parents must provide an emergency phone number before their 9-11-year-old may come to the pool without their supervision.

#### SKILLS TO BE TESTED:

25 yards freestyle 25 yards breaststroke Dive from edge of pool Tread water for two minutes Knowledge of what to do in 25 yards backstroke

25 yards elementary backstroke Retrieve ring from bottom of deep end

Knowledge of safety rules a pool emergency

The above skills must be demonstrated to the acceptance of the tester.



The pool will be closed to the public during the parties. The Hanford pool will remain open for residents to enjoy.

Our pools will close early if the weather dictates or if there are problems that create a health concern. If any of these problems occur, please be understanding. We are working with the local health depart-

the pools will be closed due to a biohazard (the minimal amount of time is 30 minutes but it could be extended depending on the pool chemical readings or the type of biohazard that occurred). Please keep biohazard accidents to a minimum by following a few simple guidelines:

- 1. Don't let children use the pool if they are not feeling well.
- 2. Wait an hour after eating before swimming.
- 3. Have your child take regular bathroom breaks.
- 4. Follow the diaper rule.
- 5. Have your child sit out to rest for a while if he/she has swallowed a lot of water and has come up gagging.

Did you know that lightning can strike up to 10 miles from the eye of the storm? That's why the pool staff closes the pool when there is lightning. If the staff calls lightning, please leave the pool area immediately. The pool will remain closed for one hour after the last streak of lightning.

Your cooperation is essential for a smooth running pool season!

# **POOL RULES**

# ONLY RESIDENTS WHOSE DUES ARE PAID IN FULL, INCLUDING ALL PREVIOUS YEARS, WILL BE ABLE TO USE THE FACILITIES.

- 1) NO swimming unless a lifeguard is on duty.
- 2) WALK (no running, rough play, splashing or dunking is allowed in the pool area).
- 3) Showers must be taken before entering the pool area (state health code).
- 4) NO gum or food is allowed in the pool area. NO glass containers (or ceramic coffee mugs) or alcoholic beverages (state health code). Use of the pool prohibited after consuming alcoholic beverages.
- 5) <u>ABSOLUTELY NO DISPOSABLE DIAPERS</u>. All children not toilet trained must wear a regulation swim diaper or cloth diaper and rubber pants that fit snuggly at the waist and legs.
- 6) Children under the age of 6 must be accompanied in the water by an adult or qualified helper.

HELPER QUALIFICATIONS (must meet them all):

- At least 14 years old (18 years old if watching a child under 6).
- Be on record as passing the RED DOT TEST.
- May only watch one child at a time.
- Must be present on the pool deck at all times.
- Guest pass required if helper is not a Sunflower resident.
- 7) Children under age 12 must be supervised by an adult, guardian or helper at all times.
  - Note: Children ages 9-11 who pass the RED DOT TEST may use the pool unsupervised.
- 8) Childcare providers, ages 15-17, may accompany children ages 6-12. For children under the age of 6 the childcare provider <u>must</u> be 18 years of age or older. All childcare providers must be registered with the association office. Guest pass required if childcare provider is not a Sunflower resident.
- 9) Small plastic pool toys (that fit in the palm of a hand) with no sharp edges or removable parts are allowed in the pool area.
  - NO balls, noodles, dolls with hair, flotation toys, SCUBA gear, or masks.
- 10) BAND-AIDS must be removed before entering the pool area (state health code).
- 11) NO hanging on the rope, ladders or rails.
- 12) Diving permitted in designated areas ONLY. NO jumping in backwards, spinning, flips or jumping from ladders or stairs.
- 13) Proper swim attire is required NO cutoffs or shorts allowed (state health code).
- 14) NO shoes or agua footwear are allowed in the pool.
- 15) The lifeguards reserve the right to limit the number of patrons in the pool facility.
- 16) NO UNNECESSARY CONVERSATION WITH THE LIFEGUARDS.
- 17) The Guard Room, stands and other equipment are for lifeguard use ONLY. Please refrain from entering the designated red lifeguard zone around the stands.
- 18) The Kiddy pool is for children age **5** and under (10 people maximum). Adult must accompany child at all times. Kiddy pool will be closed during adult swim.
- 19) NO playing in restrooms or lengthy showers. Showers are to be taken ONLY when coming into or leaving the pool area. CHILDREN ARE NOT TO TAKE SHOWERS DURING ADULT SWIM UNLESS THEY ARE LEAVING TO GO HOME!
- 20) Only audio devices with headphones are permitted in the pool area.
- 21) The chaise lounges and any other outdoor furniture are reserved for adult use.
- 22) ALL non-residents must be accompanied by a resident and a guest pass must be presented at the gate. Each lot number is allowed no more than six guests at one time.
- 23) NO ONE is allowed in the clubhouse while using the pool facilities.
- 24) This facility is a smoke-free environment. NO smoking allowed inside the fenced pool area or restrooms.

SUNFLOWER EMPLOYEES HAVE THE AUTHORITY TO ENFORCE ANY WRITTEN OR UNWRITTEN RULE THAT WILL HELP ENSURE THE SAFETY OR ENJOYMENT OF OUR PATRONS AND STAFF. ANY PATRON NOT COOPERATING AND/OR NOT OBSERVING ALL RULES WILL BE ASKED TO LEAVE THE FACILITY.



Sunflower is also home to lots of animals that wander into the streets. Please be alert and give our furry and feathered friends a chance.



# **COMMONS SENSE** Please use — don't abuse

Homeowners are not allowed to cut down any trees in Sunflower's Commons. The Commons are protected by the forestry laws of the State of Michigan. Therefore, the association must go through the appropriate channels to get approval to cut down trees - and only dead trees can be cut down.

Our commons areas are not to be used as dumping grounds. If you see someone dumping any refuse — grass clippings, shrubs, tree limbs, furniture, etc. — please call the Canton Police at (734) 394-5400 and file a complaint. There is a dumping ordinance that the police can enforce: the offender will either receive an appearance ticket on the spot or a misdemeanor warrant will be issued. The fines for dumping are up to \$500. There is weekly, curbside pick-up service for this refuse.

Utilize our commons for your leisure and recreational needs but remember, these are private parks, not public parks. If you are involved with an "organized" community activity, it is the responsibility of your group to find the appropriate, not just most convenient, place to gather.

The Commons in Sunflower are not an extension of homeowners' backyards. Residents are not allowed to install or leave personal property in the commons areas. This includes, but is not limited to, play structures, barbecue grills, lawn furniture, fences and/or invisible fences and any type of recreational equipment. All personal property belongs in the homeowner's yard. All trees planted in the commons areas must have site approval by the Board. No more than two trees behind or beside a lot will be approved.

Tree houses may be built on your property, but please do not build them in the commons. Please do not build bike ramps in the Commons, which destroys the natural undergrowth in the wooded areas. When playing ball in the Commons, please be courteous toward the homes bordering the Commons. Please don't hit the ball toward the homes or run into the fences or climb the fences to retrieve your ball.

Enjoy the natural state of our woods and commons!

#### **COVENANTS AND RESTRICTIONS**

If you want to know what can and cannot be done on your property be sure to check the Covenants and Restrictions for your lot. The C&Rs are available through the Sunflower Website (sunflowercanton.com).

SVHA office staff cannot interpret or offer assistance about C&Rs. Have the C&Rs reviewed by personal legal counsel to ensure that what you wish to do is not in conflict with the Covenants & Restrictions and then come to the SVHA Board with your questions.

# **Tips from Canton Public Safety**

Take a few common-sense steps to make your home safer while you enjoy your summer vacation:

- \* Have timers go on/off at different times in different rooms, i.e. dining room around meal time, family room in the evening, bedroom around bedtime.
- Ask a neighbor to watch your house and take in your mail, paper and/or packages. If the neighbor is going inside your home have them change the blinds every so often so it looks like you're home.
- Hire a neighborhood teenager to mow your lawn.
- Have a neighbor park a car in your driveway. If the car is moved every-so-often, it appears that someone is home.

A few simple steps might give you added peace of mind so you'll enjoy your vacation more.

# Securing your home

- \* Meet your neighbors and ask that they look out for anything suspicious.
- Make sure your home address is visible.
- Make sure trees/shrubs are trimmed (dense landcaping can conceal front door entrance).

#### **SUNFLOWER ROADS - UPDATE**

With spring and summer come road construction season. The Board participated in the Canton Township road match program (also known as the Township Initiative Funding Program) and saw more than 20 sections of subdivision roads repaired during the summer of 2020. Because Sunflower roads were repaired last summer, our subdivision is ineligible for major repair work during the summer of 2021. The Board and the Roads Committee continue to monitor the road match program, and while the details for the next program are yet to be released, the Board has expressed Sunflower's desire to participate once again.

In previous years, subdivisions were asked to contribute 20% of the amount of work to be completed, and the township made a contribution of the remaining 80%, up to a maximum allocation of \$200,000. In order to participate in the 2020-21 program, Sunflower's contribution was \$40,000 and Canton Township's contribution was \$160,000. No specific details have been released for the next program, but the Roads Committee is anticipating that it will be similar. The Board is prepared to once again apply for the maximum allocation and contribute the appropriate funds necessary to receive these benefits.

The Board is aware of several areas of Sunflower that require not only major road repair, but actually need to be completely reconstructed. Some of these roads include Swanmere Drive, Lambeth Way, South Lambeth Court, North Lambeth Court, Oak Manor Court East and Oak Manor Court West, to name of few. Members of the Board have been reaching out to Wayne County for assistance. However, road repair work is expensive. The cost to replace a section of road such as Swanmere Drive would easily exceed one million dollars. The road match program is designed to assist with road repair work, not the rebuilding of roads, and would not cover these costs. Recently, our County Commissioner, Melissa Daub, contacted the Wayne County Department of Public Services for assistance on behalf of Sunflower residents. The Wayne County Deputy Director of Roads issued the following response to her inquiry:

Pursuant to your inquiry regarding the above captioned location an assessment of the area was made and it appears that extensive concrete removal and replacement or a partial reconstruct is needed which is beyond routine road maintenance. We do not do this extensive work in subdivisions because they were not built by the County. However we do provide routine road maintenance which includes pothole patching, catch basin repairs etc and we will continue to monitor and do so until a more permanent solution is facilitated. Additionally, historically when subdivision roads have needed capital improvements, it was handled through the Association, a Special Assessment District (SAD) or in recent years through the Township Initiative Funding.

As frustrating as this is, the Board of Directors and the members of the Roads Committee remain committed to working through the system and seeking an option that will work best for Sunflower.

#### **Clubhouse Rentals**

As of this printing, the clubhouses remain closed to rentals. After discussing this situation with Canton Township and other nearby venues, the Board of Directors has decided to follow state recommendations that limit the number of attendees for indoor meetings, nd has made the decision not to open the clubhouses for rentals at this time.

# **NO Skateboarding on the Sports Courts**

The weather is turning warmer, and the tennis court, pickleball courts and basketball court are calling our names. The nets have been put up and the gates are unlocked — the courts are open for use, but we ask that you use the courts appropriately.

DO NOT use the athletic courts for bike riding, skateboarding, inline skating or dog training. The surface of these courts is a special compound that is easily damaged by improper usage. Even the rubber wheels found on inline skates or bicycle tires can cause cracking and permanent damage to the surface, making the courts unsuitable for sports play.

Replacing the court surface is extremely expensive. All the surfaces were replaced last summer, and should last for several years if we all work together.

### **Golf Carts in Sunflower**

Recently several golf carts have been spotted zipping around Sunflower. According to the Michigan Public Act of 2014, golf carts are required to obey the same rules of the road as motor vehicles. Golf carts that travel on streets must be registered and insured, and be street legal, possessing horns, windshields, headlights, taillights and working turn signals.

Golf carts may **not** be operated on sidewalks, commons areas, walking paths or on private property. They may not exceed 15 m.p.h., and are not legal 30 minutes before sunset until 30 minutes after sunrise. Operators must be 16 years of age with a valid driver's license.

If you are planning on driving your golf cart through the subdivision, please be sure you are acting responsibly.


- Q: How many courts are located in Sunflower?
