#### C. Maintenance Manager - Ken Zakalowski

#### Weekly check of both clubhouses for problems.

We had a problem with a urinal running and overflowing at Hanford during a rental. Came in and disassembled the flush valve, we had two used diaphragms in boxes in the storeroom but no new ones. Cleaned up the unit the best I could and reinstalled it. Purchased new urinal kits and replaced all the diaphragms in all the urinals at both clubhouses.

Monthly preventive maintenance completed at both clubhouses.

Clubhouse rental checklists completed after rentals at both clubhouses.

All the lower windows were cleaned inside and out at both clubhouses.

Looked at a tree in the commons behind 46482 Oak Manor Ct. The tree is dead and losing branches, I think we can wait till next year to have it taken down.

A homeowner reported a washout near the catch basin and AT&T pedestal in the woods of the common area off of Burgundy. Took a look at the area, and we will have to have a camera run down the drain to see if the tile is broken causing the washout.

#### **Gainsborough:**

Wayne and I removed the limb overhanging a homeowner's backyard behind Gainsborough, we also trimmed back brush and trees around the pickleball courts.

Checked fencing around the pickleball court, found one pipe support missing and numerous fence ties broken. Located the missing pipe in the landscaping by the pool. Reinstalled the pipe and tightened all nuts-and-bolts around the complete perimeter of the court. I also removed broken fence ties and reattached all loose fence ties. Replaced missing fence ties around the pickleball court.

Crain Heating & Cooling was out to do Commercial Rental Inspection Heating Certificate check on the 3 furnaces.

Replaced the leaking faucet in the basement women's restroom, also replaced the water supply lines to the faucet.

#### Hanford:

Filled in some potholes in the parking lot with cold patch. Cleaned up loose debris around the potholes.

Weed whipped the parking lot, all the curbs and sidewalks.

Wayne and I started the cleanup under the 5 evergreen trees to the west of the clubhouse. We cut down all the scrub trees and weed whipped the area. Tied up all the branches and put aside for trash day. We found grass

clippings and old tree debris thrown under the west side of the evergreens. One of the homeowners on Weathersfield Way behind the hill is doing it as our lawn service doesn't catch any grass.
