2027 deposit for Canton road fund matching 10 K from roads fund deposited with 30 K due in future (40K total with potential 200K payback.)

Township engineers says "peckering" of recently surfaced roads not a problem.

Format for 4 sessions of lessons. Proposing more sessions limited to 3 To reduce #s of children/session.

Shawn has finished backups of computers. Fema only covers residences, not HOA Parking lot signs – no trespassing, etc.

Fence done. Anti- siphon done. UTV is road ready. Waiting on license sticker New locks for GB pool deck - ordered new ones will install next week.

Pool Chemistry validation and and bacteria testing monthly can be done by Bill Muse to replace services currently with Environmental (save \$)
